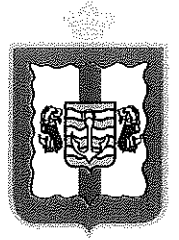

MEMORANDUM OF UNDERSTANDING

Sister Cities Agreement between the Communal Council of Dakhla and the City
of Great neck

The communal council of Dakhla , Kingdom of Morocco, and the city of Great
neck the United States of America.

Hereinafter referred to as Parties,

Desiring to strengthen

Desiring to strengthen the friendly and cooperative relations between the two
Cities ;

Desiring to contribute to the mutual understanding and cooperation between
the Governments and people of Morocco and the United States of America .

Desiring to establish the friendship and cooperation relationship in
accordance with their competencies, on the basis of mutual respect, equality and
mutual benefit, in conformity with the national laws and policies in force in
Morocco and the United States of America and the international applicable
treaties to which the two states are Parties.

Have agreed as follows

Article 1 : Scope

The Parties agree to promote exchange and cooperation in culture, art,
academia, development, environment and tourism promotion.....

Article 2 : Funding

All the activities established by this Agreement will be executed in accordance with the financial competency of each signatory. Budgets for covering expenses arising from the implementation of cooperative activities within the framework of this Agreement will be discussed and agreed upon by the Parties.

Article 3 : Joint undertaking

With the consent of both Parties, the Parties shall strengthen exchange and promote specific projects in the agreed fields.

Article 4 : Settlement of disputes.

Any disagreement that may arise between the Parties that relates to the explanation and implementation of this Agreement shall be resolved amicably between the Parties.

This Agreement may be amended or supplemented by mutual consent of the Parties. The amendments or supplementations will be made in writing which indicate the specific point of time when such amendments or supplementations take effect. The written amendments or supplementations will be an integral part of this Agreement.

This Agreement shall take effect from the date of its signing and remain in force for an undetermined period, unless either signatory sends a written notification to the other signatory of his intention to terminate this Agreement. In this case, this Agreement will be terminated three (03) months after the reception of such a notification.

The termination of this Agreement shall not affect the implementation of the on-going programmes and projects between the Parties within the framework of this Agreement until such programmes and projects are completed, unless the Parties have otherwise agreed.

ARTICLE 5 : FINAL PROVISIONS

This Agreement shall come into effect on the date of its signature. It shall remain in force for undetermined period, unless one side inform the other, by writing, its intention to terminate this Agreement, In this case, this Agreement will be terminated three (03) months after the reception of such notification.

The termination of this Agreement will not affect the ongoing programs and projects between the Parties within the framework of this Agreement unless the Parties have otherwise decided.

This Agreement may be amended by mutual written consent of the Parties. Such amendments will be an integral part of this Agreement. Such amendments shall come into effect in accordance with the subparagraph 1 of this Article.
